contrac2 is for Saanens that are already on the ground.  
**Unborn kids is DIFFERENT.**

Whereas, \_\_\_\_\_ wishes to buy, and  
**CAPRIKORN FARMS** wishes to sell:

Here is their agreement:

1. Price is \_\_\_\_\_. Plus \$10 for every e-mail or phone call or fax you make after the 4<sup>th</sup> one.
2. The buyer will make a \$100 deposit for each animal.  
If price is over \$1,000, 10% deposit of that Saanen's price.  
**The deposit is refundable anytime the buyer changes their mind.**
3. **THERE IS NO DEAL UNTIL THE DEPOSIT ARRIVES.** Telling us that you are going to buy someone is completely meaningless.
4. **The first deposit wins** when two buyers want the same Saanen.
5. The buyer will pay all shipping costs, including any crates. The crate is refunded when the buyer sends it back. If your baby is flying, our charge to the airport and dealing with DELTA is \$95. If Caprikorn transports the cost is .75/mile plus motels at \$95 each. As of March 2019 crate is 129.99, airplane kit is 24.99, total with tax is 164.28.  
**For people that reserve the kid in advance of birth there is a smaller crate that is more like \$86.**  
We charge you the same thing that we pay for the crate. Shipping Paper is \$75.
6. Shipping promptly at 15 days from signing this contract.  
If the buyer delays the shipping past that date then the buyer has to pay boarding of \$4.50 per day per dry animal, \$3 per day for milker. The boarding is subtracted from the deposit. Once the deposit is used up, the buyer no longer has a deal. If the buyer doesn't want to pay boarding, they should notify the seller to send the deposit back.
7. PREGNANCY STATUS If the buyer delays pickup beyond 30 days, and the seller gets the doe pregnant, the seller CAN increase the price. This accounts for the value of the kid(s). Otherwise the price never changes. If the buyer does not want kids, they should ship within 30 days of making their deposit.
8. Included in price we will/will not mark thru one! breed these goats.
9. The buyers DO have the right to TURN DOWN an animal.
10. The seller has insured the kids do not contract CAE. The seller does c.a.e test on the whole herd 2 and sometimes 3 times a year.
11. On a buck kid, the seller will contact the buyer if there are any flaws. If the kid has a final score of Very Good from the Appraiser the seller may not have time to do this.

- 12. Any disputes to be resolved under the laws of the state of Maryland.
- 13. This contract is void if another deposit is received before the buyers.

- 14. The quoted price means right now. In future days/weeks/months/years the sellers may change the price. Prices change all the time.

When the deposit is received, the price is fixed. The Seller has to sell at that price for the next 30 days, no matter how much the animal goes up in value through DHI or show wins or whatever.

- 15. If your goat is pregnant when you buy it, and you bring it back for a full refund, then you have to bring all the kids back also.
- 16. Each animal must have been sired by the specified buck, not some other buck.
- 17. The buyer can return the animal for a complete refund of the purchase price anytime up to one year. Minus 40 for each descendent. Minus one-half without a Negative CAE test.
- 18. Other sellers charge you ADGA fees for registration papers, and then they remove the collars. Caprikorn Farms pays these things for you. But see item 17.
- 19. This contract is not transferrable.
- 20. In the unusual case where the buyer wants to register, and there are babies in utero at the time of purchase, the buyer will fill out Service Memo's and Registration Applications and the seller will sign.
- 21. For Domestic shipments, The seller will pay for the shipping papers.
- 22. If you need paperwork more than a year after you buy your Saanen, there is a \$95 charge for every paper. There will be an additional \$95 charge for every year.  
(Example 3 years is \$285)
- 23. If I, the buyer, forward the deposit but never sent a signed contract, then a signed contract will be deemed to have happened at the same time that the deposit was received.

24. EXPORTS: THE OTHER GOAT EXPORTERS ARE MIDDLEMEN AND CHARGE YOU MORE FOR THE GOAT TO COVER THE EXTRA EXPORT COSTS. Your price at CAPRIKORN is the same as the price for a U. S. Customer who picks up the Saanens at Caprikorn Farms. However you must pay each extra cost that is caused by the fact that you are NOT picking up at Caprikorn Farms. YOUR country causes costs beyond the costs created by a normal U. S. sale. That includes quarantine, if necessary, health tests, USDA fee, dealing with approximately 7 veterinarians, transportation to the Export Airport and then later to the airplane, shipping crate, airplane kit. We have done this many times and can give you an estimate of each of these costs.

YOUR FIRST STEP IS TO OBTAIN AN IMPORT PERMIT OR A STATEMENT OF THE REQUIRED VET TESTS FROM **YOUR** country,

The second step is we will tell you if **YOUR** country's requirements on the Import Permit are doable. We have to deal with four U.S. Veterinarians plus whatever unusual laboratory tests that **YOUR** country requires. Each country is different! The export vet fees are part of your shipping costs. In addition there is a flat charge of \$295 U.S. for this paperwork and assisting the vets, plus the USDA fee. The USDA fee changes each year, but as of July 2017 it is \$121 for the first Saanen and \$7 for each additional Saanen. We start the tests AFTER you have your import permit from your country. Laboratory tests which your country wants in addition to the usual brucellosis and TB are a small extra charge. Canada is an extra \$95. Sometimes if the goat is flying, there is a charge to transport from the farm to the export airport (New York or Miami) and then from the quarantine airport site to the airplane itself. If we feel that your country or the lab tests create too many problems, the sellers may cancel. This has only happened to us one time. Russia. Often the veterinarian process is too slow and your permit is about to expire so we have to drive to the Harrisburg USDA office. That costs you \$151.74 - .75 cts per mi RT.
